## **Tech Report:**

# Fastrack:

- Small classing changes
- Proposal to not allow > 95 octane in some classes

## **Event sites:**

  - We could run the event as a HouSCCA event and TAMSSC would count it as their regional. HouSCCA would provide timing, insurance, etc. and would keep all the money except some fee we negotiate with TAMSSC.
